OFFICE ORDER

Subject: Pre-registration of SAS/I/CPD Examinations in Examination-2 of 2022-reg.

Headquarters' office, vide letter no. 421/13-Exam/Examination-1/2022 dt, 27.09.22, has intimated that the registration process for the SAS/I/CPD-I,II & III Examinations in Examination-II of 2022 will commence from 3rd October 2022 and will end on 21st October 2022. Applications are therefore, invited for pre-registration of candidature for Examination-2 of 2022 (SAS/I/CPD) from officials fulfilling the eligibility criteria as mentioned below.

1. SAS Examination:-

i). Officials who were declared to have passed the Preliminary Test for SAS Examination-I of 2022 and Divisional Accountant or Divisional Accounts Officer-II, who have successfully completed their probation period on or before 1st September'22.

ii). Vide Headquarters' Circular No. 11 of 2020 dt. 19.10.20 the total chances to pass the SAS Examination has been increased from ten to twelve (6 normal + 6 additional).

iii). The additional six chances will be admissible only to those candidates who have cleared five papers within first(normal) 06 chances. Six additional chances will not be consecutive as earlier but the time limit for passing the SAS Examination will be eight years considering two examinations in a year (8 years for 12 chances) w.e.f SAS Examination-I of 2022.

iv). Those who have already exhausted ten chances will be allowed two more chances from SAS Examination-I of 2022 and has to avail these two chances within two years.

2. Incentive Examination*:-

i). Sr. Accounts Officer (Sr. AO)/Sr. Divisional Accounts Officer (Sr. DAO) are eligible to appear in Incentive Examination.

ii). Divisional Accounts Officer Gr.-I/Assistant Accounts Officer (AAO) who have completed one year continuous service in the grade/cadre as on 1st September'22.

3. CPD I/ II & III Examination*:-

i). Sr. AO/Sr. DAO are eligible to take the first CPD test. AAO/DAO Gr.-I who have completed four years of continuous service in the grade/cadre as on 1st September'22 are eligible to appear in CPD-I Examination.

ii). Sr AO/Sr. DAO/AAO/DAO Gr.-I after elapse of four years from qualifying their first CPD test are eligible to appear in CPD-II Examination.

iii). The third and final CPD test can be taken by the Sr. AO/Sr. DAO/AAO/DAO Gr.-1 after elapse of three years from qualifying their second CPD test.

* Vide Circular No. 03 of 2021 dt. 13.04.21, Headquarters' office has permitted to avail two additional chances as a one-time opportunity to existing candidates of Incentive/CPD-I & II Examination who have exhausted all permissible six chances but could not clear the Examination. These Two additional chances should be availed in four Examination w.e.f Examination –I of 2021 during two years i.e 2021 & 2022

In view of the above, a single pre-registration form may be submitted by the officials clearly indicating the Exam(s) in which s/he intends to appear. Separate pre-registration forms are not required to be filled up for each examination. Officials are required to submit duly completed Pre-registration form in the enclosed format to Trg & Exam section or through email at <u>agaebihar@cag.gov.in</u> by 14.10.22. The details of examination schedule will be intimated in due course.
