

Madam/Sir,

References have been received in the Training Division/HQ to strengthen the SAS training imparted to departmental candidates (Groups B & C). Further, the CAG has assured the Group C and D association to strengthen SAS exam training.

2. The Training division, vide DO letter no. 179-Trg.Div/32-2012 dated 21.05.2014 (enclosed), had circulated the two-month (240 sessions) training mechanism for preparing the departmental candidates for the SAS examination. The undersigned is directed to reiterate that the field offices may follow the mechanism circulated vide ibid circular to strengthen in-house training for departmental SAS aspirants and also counsel them for ensuring quality and effectiveness of the training.

3. It is also informed that the Training Division in conjunction with NAAA/RTIs/RTCs has created a Knowledge Repository for all material related to SAS examination. This knowledge repository can be accessed by all employees of the department through the SAI Training portal by logging into the portal as a general user, and going to the "Knowledge Repository" page under reference materials.

4. Field offices can also seek the assistance of RTIs/RTCs, if required, for organising a few sessions online.
