3) Having been authorized by the Directorate of Accounts, Government of Goa in their letter No. DA/PA-I/Pens/2022-23/TR-739/DR-1832 dated 19-10-2022, it is requested to make necessary arrangement for payment of dearness relief to all eligible Goa Government pensioners/family pensioners mentioned above directly @ 203% on their basic pension/family pension with effect from 01-01-2022 after proper adjustment.
