Consequent on merger of the post of Audit Officers/ Accounts Officer and Sr. Audit Officers/ Sr. Accounts Officer vide Hqrs. letter No.1327-Staff (Appt.)/213-2019 dated 25.11.2019 and in terms of the provisions contained in the Modified Assured Career Progression Scheme (MACPS) for the Central Government Civilian Employees, as introduced by the Govt. of India vide Ministry of Personnel, Public Grievances & Pensions (Department of Personnel & Training) OM No. 35034/3/2008-Estt. (D) dated 19th May, 2009, circulated vide CAG's office letter No. 28-Audit (Rules)/8-2009 dated 20.05.2009 read with clarifications contained in OM No. 35034/1/97-Estt.(D) dated 04.10.2012, O.M. No. 35034/1/2015-Estt.(D) 27/28.09.2016, O.M. No. 35034/3/2015-Estt.(D) dated 22.10.2019 and Hqrs Circular No. 23-Staff wing/2016 dated 20.06.2016, the following officers of Group 'A' Gazetted post (Sr. AO cadre only) are hereby given financial up-gradation in the level of Pay-matrix from the date shown against each:

Grant of financial up-gradation under the MACP Scheme shall only be on personal basis and shall not tantamount either to functional/regular promotion or to change in the existing designation/status of the concerned official. It will also not change the existing seniority position thereof. However, financial and certain other benefits, which are linked to the pay drawn by an employee, shall be permitted. No stepping up of pay in the pay level would be admissible with regard to junior getting more pay than the senior on account of pay fixation under the MACP Scheme.

With regard to fixation of pay on grant of financial up-gradation under the MACP Scheme, the concerned official may exercise the option for pay fixation under Rule 10 of Central Civil Services (Revised Pay) Rules, 2016, read with clarifications of the Dept. of Expenditure's OM No. 4-21/2017-IC/E.IIIA dated 28.11.2019. In case of an official getting two or more financial up-gradations, his/her pay shall be fixed successively in each level of pay-matrix.

There shall be no further fixation of pay at the time of regular promotion, if it is in the same level of pay-matrix as granted under MACPS. However, at the time of actual promotion, if it happens to be in a post carrying higher level in the pay-matrix than what is available under MACPS, no pay fixation would be available and only difference of level would be made available.

In case the concerned official, after being granted financial up-gradation under the MACPS, refuses the regular promotion, he/she shall not be eligible to be considered for further financial up-gradation, till he/she agrees to be considered for promotion again. The next financial up-gradation shall also be deferred to the extent of period of debarment due to such refusal.
