Subject: Grant of dearness relief to the Tamil Nadu Government pensioners/family pensioners with effect from 01-07-2022.

In continuation to this office circular No. Pen. Co-ordn./Tamil Nadu/Vol.-VII/DR/177 dated 03-03-2022, this is to state that the Government of Tamil Nadu in their G.O.Ms. No. 257 dated 18-08-2022 has sanctioned dearness relief to their pensioners/family pensioners as under:

Rate of dearness relief per month Date of effect 34% of basic pension/family pension 01-07-2022

- 2. The amount of dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee if such fraction is 50 paise and above and shall be ignored if it is less than 50 paise.
 - 3. This order will apply to the following categories of pensioners:
- Tamil Nadu Government pensioners, teacher pensioners of aided and local body educational institutions and other pensioners of local bodies.
- Tamil Nadu Government employees who had drawn lump sum payment on absorption in Public Sector Undertaking/Autonomous body/Local body/Co-operative institution and have become entitled to restoration of commuted portion of pension as well as revision of the restored amount.
- Present and future family pensioners; in the case of divisible family pensioners, dearness relief shall be divided proportionately.
- Former Travancore-Cochin State pensioners drawing their pension on 1st November, 1956 in the Treasuries situated in the areas transferred to Tamil Nadu State on that date, i.e. Kanniyakumari District and Shencottah Taluk of Tirunelveli District.
- Pensioners who are in receipt of special pensions under Extra-ordinary Pension Rules, Tamil Nadu and Compassionate Allowance.
- 4. Having been authorized by the Accountant General (A&E), Tamil Nadu in their authority No. AG(A&E)/Pen-29/V/Mail/2022-23/ dated 13-10-2022, received under letter No. AG(A&E)/Pen-29/V/Mail/2022-23/40065 dated 21-10-2022 as well as AG(A&E)/Pen-29/V/Mail/2022-23/20 dated 21-10-2022, received under e-mail dated 21-10-2022, it is requested to make necessary arrangement for payment of dearness relief to the aforesaid categories of Tamil Nadu Government pensioners/family pensioners @ 34% on their basic pension/family pension with effect from 01-07-2022 after proper adjustment.
- 5. The charges on this accounts are debitable to the head "8793-I.S.S. A/cs.; Government of Tamil Nadu etc."
