Subject: Grant of dearness relief to the Uttarakhand Government pensioners/family pensioners with effect from 01-01-2022.

In continuation to this office circular No. Pen. Co-ordn./Uttarakhand/Vol.-II/DR/16 dated 22-04-2022, this is to state that the Government of Uttarakhand in their FS O.M. No. /XXVII(7)02/2016 dated 31-05-2022 has decided to sanction dearness relief for their pensioners/family pensioners whose pension/family pension has been revised as per recommendation of the 7<sup>th</sup> Central Pay Commission at the rate and from the date as under:

Date of effect	Rate of dearness relief per month
01-01-2022	34% of basic pension/family pension

- 2. Payment of dearness relief involving a fraction of a rupee shall be rounded off to next higher rupee.
- 3. These orders will also be applicable to such teaching and non-teaching pensioners of Institutions aided from the State of Uttarakhand under the Education/Technical Education Department whose pension/family pension is at par with the pensioners of the Government of Uttarakhand.
- 4. These orders will not be applicable to the Judges of High Court of Uttarakhand, Chairman and Members of Uttarakhand Public Service Commission, civil/family pensioners of local bodies and Public Undertaking Corporation etc. In respect of such categories separate orders will be issued by the respective departments.
- 5. Having been authorised by the Accountant General (A&E), Uttarakhand in their authority Nos. P.A./Pension/Uttarakhand Dearness Relief /2022-23/698 dated 06-07-2022, P.A./Pension/Uttarakhand Dearness Relief/22-23/1247 dated 12-08-2022 and 02/T.M./Specimen Signature/2022-23/700 dated 29-11-2022, it is requested to make necessary arrangement for payment of dearness relief to all eligible Uttarakhand Government pensioners/family pensioners @ 34% on their basic pension/family pension with effect from 01-01-2022 after proper adjustment.
- 6. The charges on this account are debitable to the head "8793-I.S.S.A/cs.; Government of Uttarakhand etc."
