**Sub Calling for applications from eligible fresh / repeater candidates intending to appear at the ensuing SAS/IE/CPD Examination-I scheduled to be held in May 2023.**

In terms of Headquarters Examination wing Letter No. 82/01-Exam/Exam-1&2/2023 dated 03.02.2023, Examination Wing Circular No. 10 of 2020 issued vide 370/04-Exam/MSO/Chapter 9 of Revision/2020 dated 15.09.2020 and Circular 11 of 2020 issued vide No. 75/03-Exam/Addl. Chances/2016/Vol/I dated 19.10.2020 applications in the prescribed proforma (enclosed) are invited from eligible **fresh / repeater** candidates intending to appear **SAS/IE/CPD Examination-I of 2023**. Those officials who have successfully passed the SAS (Accounts) Preliminary Examination conducted during 2023 and completed the mandatory pre-examination training are eligible to appear the said examination subject to condition that they would be completing the requisite length of service in one or more capacities in terms of Para 9.2.6 and relaxation in the said para if any issued and would be successfully completing their probation period as on 01.03.2023.

The cut off dates for determining the eligibility of the officials for SAS/IE/CPD I, II & III will be 1<sup>st</sup> of March 2023 for Examination-1 of 2023 unless otherwise notified by the competent authority in a particular year. Further the requisites for number of permissible chances to pass the SAS Examination has been mentioned in the Examination Wing Circular 11 of 2020 issued vide No. 75/03-Exam/Addl. Chances/2016/Vol/I dated 19.10.2020.

In terms Headquarters Letter No. 34-Staff (App1)/2021 circulated vide No. 1203-Staff (app 10/17-2021 dated 24.09.2021, the A&E officials (fresher's) will be allowed to write SAS (Civil Audit) Examination only if the prevailing vacancy in the cadre of AAO is less than 20%.

The intending candidates are requested to follow revised Chapter IX of MSO (Admn) Vol.I for eligibility criteria for appearing the SAS/IE/CPD Examinations. Further, Headquarters Office Examination Wing Circulars issued in this regard may also be referred for the purpose.

Hence, all eligible officers / officials of the Office of the Principal Accountant General (A&E), Odisha, Bhubaneswar including Branch Office, Puri intending to appear the above examinations scheduled to be tentatively held in May 2023 in terms of Headquarters Examination Wing letter No. 82/01-Exam/Exam-1&2/2023 dated 03.02.2023 may submit their application to Admn.I Section, duly filled in, in the prescribed pro-forma which can be downloaded from the office website (<https://cag.gov.in/ae/odisha/en/ae-circulars-office-orders?cat=853>) latest by **17.02.2023**. Applications received after due date or in incomplete shape will be rejected.

*SAS/IE/CPD-I & CPD-2 Test candidates awaiting results may apply within one week from the date of declaration of the results or the last date of submission of application, whichever is later.*
