

2. The Executive Engineer, I. & P. Division, Gonda. Shri Vikrant Yadav, Divisional Accountant (Probationer), appointed on 10.02.2023 (forenoon), is hereby posted to above division. He has been relieved from this office on 14.02.2023 (afternoon). His pay will be fixed at the stage of Rs.35400/- in 'Level-6 of the Pay Matrix'.
