**CIRCULAR**

Headquarters Office vide letter No. 82/01-Exam/Exam-I&2/2023 dated 03-02-2023 has intimated that the registration for SAS/IE/CPD-I, II & III Examinations -1 of 2023 scheduled to be held conducted from **02-05-2023 to 09-05-2023**, will commence shortly and will end on 15-03-2023. The date sheet of the examination would be intimated in due course. The cut-off date for eligibility for the examination is **01-03-2023**.

Eligibility:

1. For SAS examination, confirmed Group C officials with 2 years of continuous service in one or more post(s) in a particular field office is eligible to appear for the SAS examination.
2. For CPD examination
  - (a) All Sr. AOs are eligible to take the CPD-I examination. AAOs are eligible to appear for the CPD-I examination after completion of four years of continuous service in the grade.
  - (b) The CPD-II examination can be taken by the Sr. AO/AAO after elapse of four years from qualifying their CPD-I examination.
  - (c) The CPD-III examination can be taken by the Sr. AO/AAO after elapse of three years from qualifying their CPD-II examination.

For the registration process viz., the first part, the basic data i.e. Name, Date of Birth, Category etc., as mentioned in the Service Books of the fresh candidates will be entered into the first part of the Registration form by the Office. Thereafter, the fresh candidates will complete the second part of the Registration Form by themselves. The existing candidates will fill up the second part of the Registration Form after activation by the office. The Office will verify and validate the data entered into the online Registration Forms by the candidates to enable the Accountant General to approve their candidature. The chance of a candidate would be counted once she/he registers for the exam and there is no scope of withdrawal.

The candidates who are on deputation to other offices within the department must submit their applications directly to this office under intimation to Administration of the borrowing offices. Such candidates must make all exam related communications to this office directly for timely completion of registration process/other examination related issues.
