



2. The Executive Engineer, Minor Irrigation Division, Azamgarh. Shri Anil Kumar Meena, Divisional Accountant (Probationer), appointed on 16.03.2023 (forenoon), is hereby posted to above division. He has been relieved from this office on 17.03.2023 (afternoon). His pay will be fixed at the stage of Rs.35400/- in 'Level-6 of the Pay Matrix'. All allowances will continue to be paid at existing rates of Central Government. First increment will be released on completion of six months as on 1st July or 1st January as the case may be.
