Subject : Grant of dearness relief to the pensioners/family pensioners of Tripura Government Judicial Services with effect from 01-07-2022.

In continuation to this office circular No. Pen. Co-ordn./Tripura/Vol.- VI/DR-Judi/84 dated 10-08-2022, this is to state that the Government of Tripura in their Memo No. F.5(6)-FIN(G)/79(Part-II)/174-314 dated 17-11-2022 has enhanced the dearness relief from the existing rate of 203% to 212% with effect from 01-07-2022 to the pensioners/family pensioners of their Judicial Services.

2. Having been authorised by the Accountant General (A&E), Tripura in their letter No. Pen-1/Tripura Relief/Judicial/2022-23/14928-14963 dated 28-02-2023, it is requested to make necessary arrangement for payment of dearness relief @ 212% to all eligible pensioners/family pensioners of Tripura Government Judicial Services with effect from 01-07-2022 after proper adjustment.
