

Minutes of the Departmental Screening Committee meeting constituted for making Compassionate Appointment in the Office of the Accountant General (Audit), Telangana, Hyderabad

The Departmental Screening Committee consisting of Sri Ch. V. Sai Prasad, Director (INDT & CEA), O/o PDA(C) Hyderabad and Shri J. Nikhil Chakravarthi, Sr.DAG (AMG-II), O/o AG(Audit) TS, & Shri A. Paventhan, Director (Admn), O/o DGCA, Hyderabad met on **15.03.2023** to consider the cases for Compassionate Appointment in respect of the following applicants:

2. The Committee considered the case in compliance to Consolidated Instructions on compassionate appointment issued vide DoPT OM 14014/02/2012- Estt.(D) dated 16-01-2013 and subsequent instructions vide DoPT OM 43019/9/2019-Estt(D) dated 23-08-2021 and DoPT OM 14014/1/2022-Estt.(D) dated 02.08.2022. A balanced and objective assessment of the financial condition of the family was made taking into account, assets and liabilities and other relevant facts such as the presence of an earning member, size of the family, age of the children and the essential needs of the family etc.

3. The details of marks provided to the applicants based on the revised evaluation system as at Annexure V(ii) of Hqrs circular no 14 dated 20.04.2022 for appointment on compassionate grounds are given below:

4. Taking into consideration the financial background, four dependent members in the family and medical expenditure of medically invalidated and retired employee, Sri. B. Raju, MTS, the Committee opined that the family is indigent and deserves immediate assistance for relief from financial destitution.
5. The Departmental Screening Committee considered the financial liabilities on the family of Late Shri K. Rama Krishna, SAO and opined that, the deceased official's family comprising of two dependents with no other earning members, deserves assistance.
6. The Committee, opined that the family of Late Shri P. Gnaneshwar Rao, Clerk, comprising of 04 dependents with financial liabilities and no other earning member, is indigent and deserved immediate assistance for relief from financial destitution due to sudden demise of the only earning member in the family.
7. Considering the financial liabilities on the family of Late Shri Papayya Pantulu, Supervisor owing to the medical expenses incurred by the family, the Committee is of the view that, the family of the deceased official is indigent and deserves immediate assistance for relief from financial destitution due to sudden demise of the only earning member.
8. The Committee took note of the financial background and liabilities of the family of Late Smt. K. Sowbhgya Lakshmi, SAO. The applicant is employee in Infosys Ltd with an earning of Rs. 32,855/- per month. Other members of the family too are/ were employed with decent earnings along with source of income from property to the extent of Rs.10,000/- (as declared by the family) with no other financial liabilities. Hence the Committee opined that the sudden demise of the Government Servant does not place the family in a penurious circumstance and hence consider the case "**Not Fit**" for Compassionate Appointment. There are no liabilities whatsoever for the family, that are left unattended due to sudden demise of the employee.
9. The recommendations of the committee have been approved by the Competent Authority.
