CIRCULAR NO. 22

1. Children Education Allowance is admissible for the expenses incurred for first two surviving children @ Rs 2250/- per month per child. The allowance includes tuition fees, admission fees, etc. Also Hostel subsidy is admissible @ Rs. 6750/- per month or the actual expenditure whichever is lower. Children Education Allowance is admissible at double the normal rates i.e. @ Rs. 4500/- per month (fixed) for Divyaang (Specially-abled) children.
2. Officials may apply for Children Education Allowance for the academic year 2022-23. Application in duplicate in prescribed format may be submitted as **hard copy** only along with **ORIGINAL** bona-fide certificate clearly mentioning the name of the student, year of study, class, date of birth, name of the parent, affiliation Regd. No./code and curriculum. In case such certificate cannot be obtained, self- attested copy of the report card or self-attested fee receipt(s) {including e-receipt(s)} confirming/indicating that the fee deposited for the entire academic year can be produced as a supporting document to claim CEA. The period/year means academic year i.e. twelve months of complete academic session.
3. For Hostel Subsidy, a similar certificate issued by the Head of institution will suffice, with the additional requirement that the certificate should mention the amount of expenditure incurred by the government-servant towards boarding and lodging in the residential complex of the school. In case such certificate cannot be obtained, self-attested copy of the report card and **ORIGINAL** fee receipt(s)/e-receipt(s) which should indicate the amount of expenditure incurred by the Government servant towards lodging and boarding in the residential complex can be produced for claiming Hostel Subsidy.
4. In respect of schools/institutions at nursery, primary and middle level not affiliated to any Board of education, the reimbursement under the Scheme may be allowed for the children studying in **recognized school/institution**. Recognized school/institution in this regard means a Government school or any education institution whether in receipt of Govt. Aid or not, recognized by the Central or State Government or Union Territory Administration or by University of a recognized educational authority having jurisdiction over the area where the institution/school is situated.
5. In respect of a Divyang child who is not able to attend the school, the reimbursement of CEA for availing education / special education at residence shall be made at Rs.4500 per month with effect from 17.02.2023 on production of payment receipted by teacher/instructor etc., and self-certification by the Central Government Servant for availing education of their child at his/her residence.

6. The format of Certificate and proforma of application form is enclosed herewith the circular. Incomplete application will not be entertained.
