In partial modification of this office order No. Admn./Audit/A/2020/304 circulated vide Endst. No. Admn./Audit/Office Restructuring/2020-21/14359-14408 dated 27.11.2020, (and as amended from time to time) the allocation of 01 (one) Sr. Audit Officer (Commercial) and 01 (one) Asstt. Audit Officer (Commercial) each in the sanctioned strength of SAO and AAO/Supervisor in AMG-I and AMG-III (General Sector) has been revisited and revised by the competent authority.
