NFU will be reckoned for financial up-gradation under Modified Assured Career Progression Scheme (MACPS). Subsequent financial upgradation under MACPS, if due, will be reckoned from the date of NFU.

Due to re-fixation of pay, subsequent grant of NFU, arrears of pay and allowances shall be paid to the officers, as admissible under 7th CPC.

The financial benefits would accrue from the date of resumption of duty in case the officers is on leave on the date indicated against each officers. **They shall submit their confirmation regarding attendance of duty duly countersigned by the concerned Superintending/Executive Engineer of the Division to which they are posted to WM Section Puri Branch Office.**
