The next Departmental Examination for Auditors will be held in the month of August 2023 as per the following schedule:-

As per Hqrs. Circular No.10 of 2022 vide letter No. 145/07-Exam/Clarification MCQ Pattern/2022 dated 24.03.2022 the exam will be conducted in MCQ Pattern of Questions with 2 Hours duration. No books are allowed, Pass and exemption marks is 45% in each paper and Negative mark to the extent 0.25 marks (25 percent) is also applicable.

Passing this Examination is obligatory for Auditors (both Direct Recruits and Promotees) and a pre-requisite for confirmation and for promotion to the next higher grade viz. Senior Auditor. Auditors, who have rendered one year of continuous service as on **01.08.2023** and such of those Clerks promoted to the Auditor cadre under the seniority quota and have put in 90 days of service as on **01.08.2023** from the date of promotion or taking over charge as Auditor, whichever is later, are eligible to take the examination in **August 2023**.

Officials fulfilling the following conditions are also eligible to apply for the examination.

- Graduate Group 'C' Officials, who have put in three years of continuous service as 01.08.2023 are also eligible to take the Departmental Examination for Auditors to t held in August 2023. Graduate Group 'C' Officials on passing the Departmentan Examination for Auditors would be considered for promotion to the cadre of Auditor against the 25% examination quota.
- 2. Subject to fulfilling other conditions, Matriculate Ex-servicemen (which includes Exservicemen, who obtained the Indian Army Special Certificate of Education or the Corresponding Certificate in the Navy or Air Force), who have put in not less than fifteen years of service in the Armed Forces of the Union are also eligible to take this Examination as Graduate Group 'C'.

Application for the condonation of deficiency in service of up to a maximum limit of sixty days in computing qualifying service for appearing in the Departmental Examination for Auditors from directly recruited Auditors will be considered on merits. This condonation will also be admissible to Graduate Group 'C' Officials who apply for the examination.

Eligible candidates (including repeaters) of the Offices of the Principal Accountant General (Audit I), TN, Principal Accountant General (Audit II), TN & Puducherry and Principal Director of Audit (Central), Chennai, who have put in the prescribed period of service as on 01.08.2023 may submit their application in the prescribed form to Admn.II Section of this Office on or before 11.08.2023.

The candidates for the examination are given the option to answer the papers of the examination either in English or in Hindi. The option should be exercised at the time of their application and it should be for all the papers.

Hall Tickets for the Departmental Examination for Auditors to be held in August 2023 will be issued to the eligible candidates from **21.08.2023**. Hall Tickets should be obtained in person from Admn.II section of this Office.
