*Subject : Grant of dearness relief on revised pension/family pension of
Nagaland Government pensioners/family pensioners
with effect from 01-01-2023.*

In continuation to this office circular No. Pen. Co-ordn./Nagaland/Vol.-V/DR/190 dated 17-02-2023, this is to state that the Government of Nagaland in their FD Memo No. FIN/ROP/REL-8/87 (Vol-II) dated 30-05-2023 has enhanced the existing rate of dearness relief on the revised pension/family pension of their pensioners/family pensioners from 38% to 42% with effect from 01-01-2023.

2. Payment of dearness relief involving fraction of a rupee shall be rounded off to the next higher rupee.

3. Having been authorised by the Principal Accountant General (A&E), Nagaland in their letter No. Pen/NL-DR/2021-22/372 dated 15-06-2023, it is requested to make necessary arrangement for payment of dearness relief @ 42% on revised pension/family pension of all eligible Nagaland Government pensioners/family pensioners on their basic pension/family pension with effect from 01-01-2023 after proper adjustment.

4. The charges on this account are debitable to the head "8793-I.S.S.A/cs.; Government of Nagaland etc."
