As per the instructions of Ministry of Personnel, Public Grievances and Pension, Department of Pension & Pensioner's Welfare (copy enclosed), nation-wide Pension Adalats are to be conducted by Indian Audit & Accounts Department on 20.09.2023 for resolution of the pending PPOs. This Pension Adalat will cover the following:

- - Cases of retirement on superannuation till 30.06.2023 in which PPOs have not been
- Cases of voluntary retirement till 31.03.2023 in which PPOs have not been issued till
- Cases of death of Government servants till 31.03.2023, in which family pension has not been sanctioned till date
- Cases of death of Government servants in the performance of duty till 31.03.2023, in
- which only provisional/ordinary family pension has been sanctioned and family pension under CCS (EOP) Rules has been claimed
 - Cases wherein Death Certificate of the Pensioner has been submitted to Pension Disbursing Bank and Family pension not started within one month of receipt by the bank if the name of Family Pensioner is given in the PPO.

All the remaining pending cases may be settled urgently and updated status may be 2. intimated by 24.08.2023. The Group Officer in charge of Administration of the field offices are nominated as 'Nodal Officer" and are responsible for holding Pension Adalats in their respective office.

3. It is requested that all the necessary action to hold Pension Adalats may be taken immediately on receipt of this circular.

Redressal of pensioners' grievances is a high priority area of the Department of Pension & Pensioners' Welfare and Pension Adalats are being conducted for speedy resolution wherein all stakeholders to a pension case are brought on one platform for on-the-spot redressal.

It has been decided to convene a Nation-wide Thematic Pension Adalat on Wednesday, September 20, 2023, under the auspices of Hon'ble Minister of State (PP), exclusively to expedite the issue of pending PPOs. This Pension Adalat would cover the following:

- i. Cases of retirement on superannuation till 30.6.2023 in which PPOs have not been issued till date.
- ii. Cases of voluntary retirement till 31.3.2023, in which PPOs have not been issued till date.
- iii. Cases of death of Government servants till 31.03.2023, in which family pension has not been sanctioned till date
- iv. Cases of death of Government servants in the performance of duty till 31.03.2023, in which only provisional/ordinary family pension has been sanctioned and family pension under CCS(EOP) Rules has been claimed.

v. Cases wherein Death Certificate of the Pensioner has been submitted to Pension Disbursing Bank and

Family Pension not started within one month of receipt by the bank if the name of the Family Pensioner is given in the PPO.

3. I am enclosing lists of Government servants belonging to your Ministry/Department, including field organizations, who retired/died till the aforesaid dates and in whose cases PPOs for pension/family pension are yet to be issued as per 'Bhavishya record'. It is requested that the present status of these cases may be arranged to be sent to DoPPW latest by 10.08.2023 in the enclosed formats.

4. Based on the inputs received, 60 cases pertaining to various Ministries/Departments and their field formations would be shortlisted to be considered in the Pension Adalat to be conducted by DoPPW on 20.09.2023. The details of the cases pertaining to your Ministry/Department to be listed in that Pension Adalat would be communicated to you subsequently.

Each Ministry/Department/Organization/Field formation shall also hold their separate Pension Adalats on September 20, 2023 for resolution of the remaining pending PPOs.

Ministry of Railways, Ministry of Defence, Departments of Post & Telecom which have their independent pension processing software and set-up shall also follow the same protocols of conducting this thematic Adalat as is being prescribed above for all other Ministries.

All Pension Disbursing Banks shall also conduct the Adalats w.r.t those Family Pensioners who have submitted Death Certificate of the Pensioner and Family Pension has not started within one month of such submission till 30.06.2023.

5. For effective resolution of the delayed PPOs, it is imperative that the Ministries/Departments examine the cases of pending PPOs well in advance. While holding these Adalats, each Ministry shall ensure the presence of all concerned stake-holders viz. the retiree, DDO, HoO and PAO from the respective locations either physically or through VC. A notice, in advance, intimating the time and link for the Video Conferencing for the Adalat, should be sent to the concerned Pensioners/family members for their participation.

6. A nodal officer may please also be nominated from your Ministry/Department/Bank CPPC, who shall coordinate within your Ministry as well as with the Department of Pension & Pensioners' Welfare. The nodal officer will intimate the details of the cases being taken up in the Pension Adalat of your Ministry and also intimate the outcome of the Adalat. The details of nominated nodal officer may please be sent to Shri Ravinder Kumar, Director (kumar.ravinder66 anic.in) and Shri Dhananjay Prasad Singh, Under Secretary (singh.dp.1973 anic.in) (Tel. 011-24644632).

2. It is requested that the name of nodal officer nominated from your Ministry/Department/Bank CPPC may kindly be intimated to this Department latest by 5th August, 2023 and the present status of the pending PPOs may be arranged to be sent to DoPPW latest by 10.08.2023 in the enclosed formats, as requested in para 4 above.
