In terms of Headquarters' office circular No. 25- स्टाफ हक-II/2023 के अंतर्गत सं. 471/ स्टाफ हक-II/54-2023 दिनांक: 18.08.2023 regarding, **holding Pension Adalat**, Office of the Accountant General (Audit-II), W.B. is conducting a Pension Adalat on **20.09.2023** through **Video Conferencing** to redress grievances of pensioner's / family pensioners of this office within extant rules/ provisions of pension.

All aggrieved pensioners / family pensioners of this office are requested to convey issues, if any, that need to be redressed, in the enclosed proforma, to the Senior Audit Officer / Admn.I section of this office alongwith copies of all supporting documents at the email address: admn1pen.wbl2.au@cag.gov.in positively within **15.09.2023**. Applications should be sent their grievances through email only, with subject mentioned as "**Pension Adalat**".

The following points will be covered:


- Cases of retirement on superannuation till 30.06.2023 in which PPOs have not been issued till date
- Cases of voluntary retirement till 31.03.2023 in which PPOs have not been issued till date
- Cases of death of Government servants till 31.03.2023, in which family pension has not be sanctioned till date
- Case of death of Government servants in the performance of duty till 31.03.2023 in which only provisional/ ordinary family pension has been sanctioned and family pension under CCS (EOP) Rules has been claimed
- Cases wherein death certificate of the pensioners has been submitted to pension disbursing bank and family pension not started with in one month of receipt by the bank if the name of family pensioner is given in the PPO.

Grievances / cases involving purely legal points e.g. succession etc. will not be considered in the above mentioned Pension Adalat.

The link to join the video conference would be sent to the applicants found eligible based on valid supporting documents furnished by them.
