This special allowance is granted subject to the following conditions:-

- The element of Special Allowance granted on passing SAS Examination may be treated as standalone element i.e. Special Allowance of Rs. 360 for 1st year and Rs. 630 for 2nd year onwards
- Dearness Allowance and other allowances on Special Allowance will not be Admissible.
- Special Allowance will be admissible till the government servant is not promoted to the next higher post/grade.
- On promotion to next higher post after passing SAS examination, the element of Special Allowance shall not be taken into account for fixation of pay on promotion to the next higher post.
- On such promotion, the pay of such GS will be fixed as per Rule 13 of CCS (R.P.) Rules 2016.
