OFFICE ORDER

Subject: Pre-registration of SAS/I/CPD Examinations in Examination-2 of 2023-reg.

The SAS/I/CPD Examination -2 of 2023 is expected to be held in the month of December-2023. The Online registration for SAS/I/CPD Examination-2 of 2023 will commence shortly. The cut-off date for determining the eligibility of the officials for SAS/IE/CPD Examinations will be 01.09.2023 for Examination-2 of 2023, unless otherwise notified by the competent authority.

1. SAS Examination:-

i). Officials who were declared to have passed the Preliminary Test for SAS Examination-2 of 2023 and Divisional Accountant or Divisional Accounts Officer-II, who have successfully completed their probation period on or before 1st September'2023.

ii). In light of Headquarters' Circular No. 11 of 2020 dt. 19.10.20, the total chances to pass the SAS Examination has been increased from ten to twelve (6 normal + 6 additional). The additional six chances will be admissible only to those candidates who have cleared five papers within first (normal) 06 chances. Six additional chances will not be consecutive as earlier but the time limit for passing the SAS Examination will be eight years considering two examinations in a year (8 years for 12 chances) w.e.f SAS Examination-1 of 2021.

2. Incentive Examination*:

i). Sr. Accounts Officer (Sr. AO)/Sr. Divisional Accounts Officer (Sr. DAO) are eligible to appear in Incentive Examination.

ii). Divisional Accounts Officer Gr. I/Assistant Accounts Officer (AAO) who have completed one year continuous service in the grade/cadre as on 1st September'2023.

3. CPD I/ II & III Examination*:-

i). Sr. AO/Sr. DAO are eligible to take the first CPD test. AAO/DAO Gr I who have completed four years of continuous service in the grade/cadre as on 1st September'2023 are eligible to appear in CPD-I Examination.

ii). Sr AO/Sr. DAO/AAO/DAO Gr I after elapse of four years from qualifying their first CPD test are eligible to appear in CPD-II Examination.

iii). The third and final CPD test can be taken by the Sr. AO/Sr. DAO/AAO/DAO Gr.I after elapse of three years from qualifying their second CPD test.

In view of the above, a single pre-registration form may be submitted by the officials clearly indicating the Exam(s) in which she/he intends to appear. Officials are required to submit duly completed Pre-registration form in the enclosed format to Trg & Exam section or through email at agaebihar@cag.gov.in latest by 18.10.2023.


