Subject : Payment of Festival Grant to the Tripura Government pensioners/family pensioners.

This is to state that the Government of Tripura in their FD Memo No. F.10(51)-FIN(Exp-II)/63(L)/308-457 dated 21-09-2023 has sanctioned Festival Grant of Rs.1800/- (Rupees One thousand and eight hundred) only for their pensioners/family pensioners for a financial year.

2. A pensioner/family pensioner can avail the grant once in a financial year and only in a single installment and for a single festival only.

3. A pensioner/family pensioner can take festival grant on the occasion of any one of the following festivals : (i) Durga Puja, (ii) Christmas, (iii) Garia Puja, (iv) Buddha Purnima, (v) Eid-Uz-Zuha, (vi) Bengali New Year, (vii) Eid-UI-Fitre, (viii) Guru Nanak's Birthday and (ix) Mahavir Jayanti.

4. The order shall come into force with immediate effect and remain in force until further order.

5. This is in supersession of earlier orders in this regard.

6. Having been authorized by the Pr. Accountant General (A&E), Tripura in their authority No. Pen-1/Tripura Relief/2023-24/16608-16615 dated 12-10-2023, it is requested to make necessary arrangement for payment of Festival Grant of Rs.1800/- (Rupees One thousand and eight hundred) only to all eligible Tripura Government pensioners/family pensioners as per instructions laid down above.

7. The charges on this account are debitable to the head "8793-I.S.S. A/cs.; Government of Tripura etc."
