*Subject : Grant of Pension Allowance to the Rajasthan Government pensioners/family pensioners with effect from 01-04-2023.*

This is to state that the Government of Rajasthan in their FD Notification No. F.12(3)FD (Rules)/2023 dated 25-07-2023 has sanctioned Pension Allowance @ 10% of the basic pension/family pension with effect from 01-04-2023 to their pensioners/family pensioners on attaining the age of 75 years.

2. Pension allowance shall be given to the pensioners/family pensioners up to the age of 80 years. No dearness relief shall be payable on Pension Allowance.

3. Having been authorized by the Accountant General (A&E), Rajasthan in their letter No. Pension Auth./K-107/Order/2023-24/2100 dated 30-10-2023, it is requested to make necessary arrangement for payment of Pension Allowance @ 10% to the Rajasthan Government pensioners/family pensioners on their pension/family pension with effect from 01-04-2023 keeping in view the instructions laid down above.
