CIRCULAR NO. WM.I/12 DATED 10.06.2020

The inter-se-seniority of directly recruited Divisional Accountants since 1992 was being determined on the basis of passing of Divisional Accountants Grade Examination and the marks obtained in that Examination. As per Headquarters Office letter no.270-Staff (App)/137-2019 dated 20.03.2020, the seniority of the directly recruited Divisional Accountants is to be fixed in the initial grade i.e, Divisional Accountants based on the Recruitment year and the rank assigned by the Staff Selection Commission in each Recruitment Year. The revised inter-se-seniority has been determined. The revised inter- se- seniority list is enclosed for information of all the Divisional Accountants. All are instructed to examine the list, and may submit representations, if any, with justification and supporting documents for not accepting the revised inter-se-seniority. Such representations must reach this office by 18th June 2020. After considering the representations, if any, the revised inter-se-seniority list will be finalised based on which the dates of promotions already availed to different higher grades would be modified and new promotion would be given.

The revised inter-se-seniority does not include:-

1. The directly recruited Divisional Accountants who joined this office but resigned from the post of Divisional Accountant without passing the Divisional Accountant Grade Examination.
2. The directly recruited Divisional Accountants who could not pass Divisional Accountant Grade Examination in the prescribed chances and were reverted to the post of Accountant.
3. The directly recruited Divisional Accountants who passed the Divisional Accountant Grade Examination but resigned from the cadre after passing SOGE Exam and transferred to O/o, the Accountant General (A&E), Gujarat, Ahmedabad.
