- 2. The maximum number of members in a team would be Twenty (18 players, one manager & one coach). A Coach (preferably a qualified license holder or veteran player) & a Manager in each team are permitted to accompany the team. Please ensure that officials who are fully aware of the Rules/Regulations and technical aspects of the game are nominated as Manager. All the participants will be treated as on tour/duty and will claim TA/DA from their parent offices. However, accommodation will be provided by the Convener and a certificate to this effect will be issued by them as per the prescribed format (enclosed). If journey is performed by any player by air (through M/s. Balmer Lawrie/IRCTC/Ashok Tours & Travels). TA claim will be restricted as per entitlement in train. However, Manager/Coach/Referees (if eligible) may travel by air. Referees will be paid Rs 500/- per day (tournament days only) by the Convener. Official nominated as Referee cannot participate as player.

- 4. In order to provide more representation and to give good performance in the competitions, good players from other local offices at your centre may be included whose teams are not participating. In order to achieve this, a few practices cum selection trial may also be arranged locally, if deemed necessary. In case of combined team of Audit and Accounts, the DG/PD/PAG/AG at the station i/c of Recreation Club will conduct selection trial to form the team.
- 5. All Zonal will be played on <u>KNOCK-OUT basis</u> & Inter Zonal will be played on league cum <u>KNOCK-OUT basis</u>. Each half will be of 45 minutes duration (45 minute, 15-minute break 45 minute) and 15 minutes of extra time (15 minute, 2-minute break 15 minute) before tie-breaker.
- 6. Two Teams from each zone i.e. Winner and Runners-up will qualify for participation in the Inter-zonal competitions. The fixtures of Zonal & Inter-Zonal will be drawn by the Central Observer (if nominated) along with Sr. Umpires and DAG/Director (Admn.)/Welfare Officer of the convener office. Winner/Runner-up team of last years may be kept in separate pools. However, it may also be ensured that team losing in semi-finals to the ultimate winner of last year does not play with the same team this year also. However, matches of remaining teams may be decided by draw of lots. The players who will be participating in the respective Zonal & Inter-Zonal tournaments may be relieved from 2.00 PM onwards daily for practice till the completion of Zonal & Inter-Zonal tournaments.

All participants are strictly instructed to keep their Identity cards with them so that they can produce the same on demand. All the teams should be provided proper kit; otherwise teams will not be allowed to participate in the tournament.

It is compulsory for all the players recruited under <u>Sports Quota since 2011</u> onwards to participate in the IA&AD tournament subject to fitness. No player may be spared for any other tournament except selection for CAG/Indian Team.
