Departmental Examination for Accountant (DEA) will be held in Multiple Choice Questions (MCQ) pattern in the month of February 2024 as per programme detailed under. However, the testing of language skills in Paper- Govt. Accounts-Codes and Manuals (i.e routine noting and drafting on given official letters/matters) will be held in descriptive mode. No books are allowed in MCQ pattern of exam. Pass and exemption marks in Departmental Examination for Accountants is 45% in each paper.

- 21.02.24 (Wednesday)- 10.30 AM to 12.30 PM.- Govt. Accounts-Law and Rules
- 22.02.24 (Thursday)- 10.30 AM to 12.30 PM.- Govt. Accounts-Codes and Manuals
- 23.02.24 (Friday)- 10.30 AM to 12.30 PM - Service Regulations.


1. Directly recruited Accountants are required to pass the Departmental Examination for confirmation and promotion to higher scale of Sr. Accountant. Directly recruited Accountants who have completed one year of continuous service as on 1<sup>st</sup> February 2024 will be eligible to appear in the examination.
2. Graduate Group 'C' officials (i.e Stenographer, DEO, Staff Car Driver) or Graduate MTS or Graduate clerks with combined regular service of 3 years are eligible to appear in the Departmental Examination of Accountant.
3. Clerks promoted on seniority basis may appear in the examination immediately after their promotion. They may however, not appear in the examination if it is held within 90 days of their promotion.
4. Candidates will have to pass the examination within six chances in six consecutive examinations held after they became eligible.
5. Eligible candidates willing to appear in this examination are required to submit application in the prescribed Performa to Trg & Exam section **latest by 02.02.24**. The syllabus of the examination may be obtained from Trg & Exam section.
6. Venue of the examination will be intimated in due course.
