SAS Preliminary Test (MCQ Pattern) for selection of candidates for appearing in SAS Examination-I and Examination-II of 2024 is going to be held on 16.02.2024. Eligible candidates willing to appear in it may submit their application in the enclosed Performa to Trg & Exam section latest by **29.01.2024**. The detailed program of the test will be intimated in due course.

Officials who would be completing 03 years of continuous service in one or more of the capacities viz. as a Clerk/Accountant/Sr. Accountant/DEO Gr. A/B/D/Stenographer Gr. II/I/Private Secretary/Jr. Translator/Sr. Translator/Asstt. Supervisor/Supervisor in a particular field office of IA&AD and who would be successfully completing their probation period by cut of date i.e 1st March 2024 for Examination-I and 1st September 2024 for Examination-II are eligible to appear for the Preliminary Test.

Those who had qualified for the preliminary test but absents or withdraws his/her candidature from the immediate next SAS Examination will be required to be re-screened in the preliminary test for eligibility to appear in subsequent examination.

Officials who could not pass five papers within the first six (normal) chances or exhausted either 12 chances or eight years whichever is earlier will also be allowed to appear afresh in the SAS Examination. Afresh means that the candidates are required to be screened through the Preliminary Test, mandatory training etc as applicable to candidates appearing for the first time.

Note: -The eligibility criteria mentioned above are provisional and are subject to continuation/extension of the existing rule for SAS Examination-I & II of 2024.
