In continuation to this office circular No. Pen. Co-ordn./Goa/Vol.-V/DR-un-rev/55 dated 21-07-2023, this is to state that the Government of Goa in their Order No. 3/2/92-Fin(Exp)/Part File-IV/200 dated 12-12-2023 has sanctioned dearness relief to the pensioners/family pensioners of Goa Government and its Autonomous Bodies/Corporation including Ex-gratia pensioners drawing pensions under C/B/D & E series, Pensao de Sangue pensioners, pensioners receiving pension under triple benefit scheme, recipients of Ex-gratia i.e. families of deceased pensioners who were governed under EFU, pensioners sanctioned pension under Education Act 15 of 1985 and drawing pension under series T and E.B., who are in receipt of pension/family pension in pre-revised pay structure/scales of Sixth Central Pay Commission, at the rate and from the date as under:

Date of effect	Rate of Dearness relief per month
01-07-2023	230% of basic pension/family pension

- 2) This relief is not admissible to the pensioners drawing pension which is granted after independence for political consideration (Ex-Rulers); Retired High Court and Supreme Court Judges for whom order will be issued separately by administrative authorities concerned; and pensioners of other states (PAO Suspense) for whom separate orders are applicable; MLA and Freedom Fighters of Government of Goa.
- 3) Having been authorized by the Directorate of Accounts, Government of Goa in their letter No. DA/PA-I/Pens/23-24/TR-1232/DR-2002 dated 22-12-2023, it is requested to make necessary arrangement for payment of dearness relief to all eligible above category of Goa Government pensioners/family pensioners mentioned above directly @ 230% on their basic pension/family pension with effect from 01-07-2023 after proper adjustment.
- 4) The charges on this account are debitable to the head "8793-I.S.S. A/cs.; Government of Goa etc."
