This is to state that the Government of Telangana in their G.O. Ms.No. 133 dated 02-10-2023 has sanctioned Interim Relief @ 5% of the basic pension/family pension of all their pensioners/family pensioners with effect from 01-10-2023. including pensioners of the Local Bodies (PR & ULBs), the institutions receiving Grants-in-Aid from the Government, Work Charged Employees who are currently drawing pension/family pension in the Revised Scale, 2020, subject to terms and conditions mentioned as under:

- 2. Interim Relief shall be shown as a distinct element of remuneration which shall be adjusted against any benefit that may accrue to the pensioners on account of revision of pension and other allowances as a result of Government of Telangana's decision on the Report of the Pay Revision Commission.
- 3. Interim Relief will not be admissible to the Officers of the Telangana State Higher Judicial Service, the Telangana State Judicial Service, All India Service Officers (AIS) and those drawing pension on UGC/AICTE/ICAR/Government of India Pay Scales, contract staff, and staff of Societies, Autonomous Institutions, Public Sector Undertakings and all those not covered under categories mentioned at para 1 above.
- 4. The payment on account of Interim Relief involving fractions of fifty paisa and above shall be rounded off on the next rupee and fraction of less than fifty paisa shall be ignored.
- 5. Interim Relief shall not count for computation of dearness relief or any other Allowances, Fixation of Pension etc.
- 6. Having been authorised by the Principal Accountant General (A&E), Telangana in their letter No. PM-OGP/VI/2023-24/TS-GO/Circular/SSA No. 1368/349081 dated 12-10-2023, it is requested to make necessary arrangement for payment of Interim Relief @ 5% to all eligible Telangana Government pensioners/family pensioners with effect from 01-10-2023 keeping in view the instructions laid down above and after proper adjustment.
- 7. The charges on this accounts are debitable to the head "8793-I.S.S. A/cs.; Government of Telangana etc."
