Where Junior is working in another field Office, the pay drawn by him from time to time be obtained from that Office and comparative statement (as below) prepared on that basis be sent to Headquarters Office.

- (b) While forwarding information in the comparative pay fixation statement (above format), it may be ensured that following issues/information has been furnished:
- (i) service details such as grant of DNIs, MACP/Promotion etc. and grant of Qualification Pay, SOGE Special pay/Allowance.
- (ii) the option exercised under FR 22 (1)(a)(1) for fixation i.e. from date of promotion or from DNI.
- (iii) comparative pay drawn by the Officials on those dates in each and every row.
- (iv) Cause of anomaly and date from which anomaly started may be clearly mentioned.
- (c) First Junior Certificate certifying that the Junior (name) is the First Junior to Senior (name) and no other Junior is existing between Senior and Junior who may be identified as First Junior for stepping up of pay of Senior.
