CIRCULAR

The Incentive Examination for Senior Accountants and Assistant Supervisors who have not passed the Incentive Exam as Sr. Accountant is scheduled to be held on 10-04-2024 (Wednesday) between 11.00 A.M. to 01.00 P.M.

The Senior Accountants in Pay Level 6 with one-year continuous service in the grade on the first of the month in which the exam is scheduled to be held i.e. as on 01-04-2024 are eligible to appear in the examination. Further, the Assistant Supervisors in Pay Level 7 who have not passed the Incentive Exam while serving as Senior Accountant are also eligible to appear for the examination. The candidates securing 50% marks and above would be granted one advance increment in their respective pay level of Sr. Accountant/Asstt. Supervisor with effect from the 1st of the month in which the examination is held i.e. as on 01-04-2024.

There will be one bi-lingual paper (English & Hindi) on "Finance, Accounts and Internal Audit". As per Headquarters' Office clarification issued vide Circular No. 10 of 2022 dated 24-03-2022, the paper will consist of 100 MCQ of one mark each for a duration of two hours. No. books are allowed in MCQ pattern. Further, negative marking to the extent of 0.25 mark (25 percent) for each wrong answer is introduced to maintain quality and guard against guess work.

The office will not provide any training for the candidates appearing in the examination nor supply any books to the candidates. The books prescribed are priced publications and the candidates should make their own arrangements to procure them. However, the candidates may make use of the copies of the prescribed books kept in the office library maintained by Record-I Section for reference.

 - 2. Chapter 2 Borrowing.

The eligible candidates who intend to appear for the above-mentioned examination should submit their applications in the enclosed prescribed format to Admn-I Section on or before 15-03-2024.
