जैसा कि प्रासंगिक नियमों के तहत अपेक्षित है, छुट्टी यात्रा रियायत और केंद्र सरकार स्वास्थ्य योजना के तहत चिकित्सा सुविधाओं का लाभ उठाने के लिए सरकारी कर्मचारी को तलाकशुदा/परित्यक्त/अलग हो चुकी और विधवा बेटियों/बहनों जो सरकारी कर्मचारी के साथ रहते हैं और पूरी तरह से सरकारी कर्मचारी पर निर्भर हैं और माता-पिता/सौतेले माता-पिता चाहे वह सरकारी कर्मचारी के साथ रह रहा हो या नहीं पर उनके ऊपर पूरी तरह से निर्भर हैं, उनकी सरकारी कर्मचारी के ऊपर निर्भरता स्थापित करने के लिए उपरोक्त परिवार के सदस्यों का 'आय प्रमाण पत्र' प्रस्तुत करना है।

इसके अलावा, सी.सी.एस. (एन.पी.एस.) नियम, 2021 के संदर्भ में, इस कार्यालय के सभी सरकारी कर्मचारी जो राष्ट्रीय पेंशन प्रणाली (एन.पी.एस.) के तहत शामिल हुए हैं या पहले से ही एन.पी.एस. के अंतर्गत सरकारी सेवा में हैं, उन्हें एन.पी.एस. या केंद्रीय सिविल सेवा (पेंशन) नियमों, 1972, या केंद्रीय सिविल सेवा (असाधारण पेंशन) नियम, 1939 के तहत विकलांगता या सेवानिवृत्ति के कारण मृत्यु या बोर्डिंग आउट की स्थिति में लाभ प्राप्त करने के लिए फॉर्म 1 (प्रतिलिपि संलग्न) में एक विकल्प 31.05.2024 तक प्रशासन (लेखा परीक्षा I) में (अधिमानत: दोपहर 03.00 बजे से शाम 04.00 बजे के दौरान) सभी कार्य दिवसों पर, उचित कार्रवाई की सुविधा के लिए प्रस्तुत करें।

CIRCULAR

As required under relevant rules, for availing benefits of Leave Travel Concession and medical facilities under the Central Government Health Scheme in favour of divorced/ abandoned/ separated and widow daughters/ sisters residing with & wholly dependent upon the Government servant and parents/step parents wholly dependent on the Government servant irrespective of whether residing with the Government servant or not, the Government servant should furnish an 'Income Certificate' of the afore-said family members, to establish their dependency.

Further, in terms of CCS (NPS) Rules, 2021, all the Government servants of this Office joined under National Pension System (NPS) or already in Government service covered under NPS are required to submit (except those who have already submitted) an option in Form 1 (copy enclosed) for availing benefits under NPS or under Central Civil Service (Pension) Rules, 1972 or Central Civil Service (Extraordinary Pension) Rules, 1939, in the event of death or boarding out on account of disablement or retirement on invalidation, in the Administration (Audit I) by 31.05.2024 (preferably during 03.00 PM to 04.00 PM) on all working days, facilitating deemed suitable action.
