**NOTICE**

In implementing the orders dated 18.07.2023 of Hon'ble Supreme Court of India, DoPT OM No 36012/1/2020-Estt.(Res-II) dated 28.12.2023 has decided to extend the benefits of reservation in promotion up to the lowest rung of Group 'A' to Persons with Benchmark Disabilities (PwBDs) employees on notional basis with effect from 30.06.2016 subject to their fulfilment of the eligibility conditions as laid down in the DoPT OM of even number dated 17.05.2022 regarding reservation in promotion to PwBD employees.

It is for information of all the concerned that the following officers/officials had joined this office against PH quota or acquired disability subsequently after their joining and submitted the required Disability Certificate duly issued by Competent Authority.
