

(res.) dated 12.04.2022. Further, in terms of para-05 of DoPT's O.M. No. 36012/11/2016-Estt (Res.1) {Pt.-II} dated 15.06.2018, the promotion shall be subjected to further orders which may be passed by the Hon'ble Supreme Court.
