The promotion of the officials is further subject to the condition that no disciplinary/vigilance case is pending against the official. In case any disciplinary/vigilance case of the type referred to in DOP&T OM dated 14.09.1992 is pending against the official or some punishment like stoppage of increment is in currency, he should not be relieved on promotion and the matter should be reported to this office immediately.

Promotion extended vide this office order, may be reviewed on subsequent clarifications/orders/instructions received from Headquarters' Office.


Orders regarding inter-se-seniority in the cadre of Auditor will be issued separately.


