OFFICE ORDER

2. They are to report to Admn.-I Section of this office to take over charge as Senior Audit Officer.
3. The promotion is being offered to the above AAOs against actual availability of vacancy.
4. The promotion is subject to the judgement dated 28.01.2022 of the Hon'ble Supreme Court of India in Jarnail Singh and others in Civil Appeal No. 629/2022 arising out of SLP (C) No. 30621/2011, and further orders that may be passed by the Hon'ble Supreme Court in the said batch of cases. Further, the promotion shall be subject to the conditions mentioned in DoPT's O.M. dated 12.04.2022.
5. In terms of para 5 of DOPT O.M. No. 36012/11/2016-Estt.(Res-I) (Pt-II) dated 15.06.2018, the promotions shall be subject to further orders which may be passed by the Hon'ble Supreme Court.
6. There shall be a probation period of 02 (two) years on their promotion to the Senior Audit Officer cadre, as per Column (9) of the schedule of the Recruitment Rules for the post of Senior Audit

Officer, notified in Gazette of India, Part II Section 3 Sub-Section (i) vide GSR No.860(E) dated 18.11.2019 published in Gazette of India on 20.11.2019.

7. They may exercise option within one month from the date of issuance of this office order for fixation of pay under the provisions of FR 22-I(a)(1)/C.C.S. (RP) Rules, 2016.

8. The promotion of these officers is further subject to the condition that no disciplinary/vigilance/Court case is pending against them. In case any disciplinary/vigilance/ Court case of the type referred to in DOP&T OM dated 14.09.1992 is pending against any of the official(s) or some punishment like stoppage of increment is in currency, he/she should not be relieved on promotion and the matter should be reported to this office immediately.

9. While report for joining as Senior Audit Officer, the officer shall declare in his/her joining report that no prosecution of criminal case(s) is/are pending as on date in any court of law, special police establishment or police station against him/her and he/she will be liable for reversion and disciplinary proceedings, if the information furnished by him/her is found to be false or any material suppression of factual information comes to notice later.
