*Subject : Grant of Domestic Help Allowance and Medical Allowance  
in respect of Jharkhand Government Judicial pensioners/  
family pensioners with effect from 01-01-2016.*

This is to state that the Government of Jharkhand in their Personnel, Administrative Reforms and Rajbhasa Vibhag Resolution No. 1459 dated 27-02-2024 has sanctioned Domestic Help Allowance of @ Rs.9000/- (Rupees Nine thousand) only per month to their retired Judicial Officers and @ Rs.7500/- (Rupees Seven thousand and five hundred) only per month to the family pensioners of Judicial Service with effect from 01-01-2016.

2. For pensioners/family pensioners this allowance shall stand increased by 30% on completion of five years from 01-01-2016 that is, with effect from 01-01-2021.

3. The said Allowance shall be paid to such pensioners/family pensioners on the basis of their self-certification in this regard.

4. Moreover, Government of Jharkhand in their aforesaid Order dated 27-02-2024 has sanctioned Medical Allowance @ Rs.4000/- (Rupees Four thousand) only per month to such pensioners/family pensioners with effect from 01-01-2016.

5. Having been authorized by the Principal Accountant General (A&E) Jharkhand in their authority No. Pen-V/Judiciary/SSA-20/2024-25/694 dated 16-07-2024, it is requested to make necessary arrangement for payment of Domestic Help Allowance and Medical Allowance with effect from 01-01-2016 at the aforesaid rates keeping in view the instructions laid down above after proper adjustment.

6. The charges of this accounts are debitable to the head "8793-I.S.S. A/cs.; Government of Jharkhand etc."
