Subject: Revision of Domestic Help Allowance and Medical Allowance to the pensioners/family pensioners of pre-01-01-2016 Tripura

Judicial Service with effect from 01-01-2016.

This is to state that the Government of Tripura in their Law Department Notification No. F.No.1(1)-SECY/LAW/MISC/2019(PART-II)/4796-863 dated 04-02-2024 and subsequent Corrigendum F.No.1(1)-SECY/LAW/MISC/2019(PART-II)/4952-5001 dated 05-04-2024 has revised the rates of Domestic Help Allowance and Medical Allowance in respect of pensioners/family pensioners of the Tripura Judicial Service with effect from 01-01-2016 as under:

- a) Domestic Help Allowance to such pensioners and family pensioners @ Rs.9000/-(Rupees Nine thousand) and @ Rs.7500/- (Rupees Seven thousand and five hundred) only per month respectively shall be admissible with effect from 01-01-2016. This allowance shall stand increased by 30% on completion of five years from 01-01-2016 that is, with effect from 01-01-2021.
- b) Medical Allowance @ Rs.4000/- (Rupees Four thousand) only per month shall also be admissible to such pensioners/family pensioners with effect from 01-01-2016.
- 2. Having been authorized by the Principal Accountant General (A&E), Tripura in their letter No. Pen-1/Tripura Relief/Judicial/2023-2024/18994-19053 dated 05-08-2024, it is requested to make necessary arrangement for payment of revised rate of Domestic Help Allowance @ Rs.9000/- (Rupees Nine thousand) and @ Rs.7500/- (Rupees Seven thousand and five hundred) only per month to the pensioners and family pensioners respectively and Medical Allowance @ Rs.4000/- (Rupees Four thousand) only per month to such pensioners/family pensioners along with arrears with effect from 01-01-2016, after proper adjustment.
- 3. The charges on this account are debitable to the head "8793-I.S.S.A/cs.; Government of Tripura etc."
