- 2. **Age Limit:** Age should not be beyond 65 years as on 23 Sep 2024.

 - (c) No annual increment/percentage increase, Dearness Allowance and House Rent Allowance shall be allowed during the contract.

- 5. Leave: Paid leave of absence may be allowed at the rate of 1.5 days for each completed month of service to the retired official hired on short term contract basis. Accumulation of leave beyond a calendar year may not be allowed.
