Such promotion is in the interest of the public service. They may submit the charge assumption report as Sr. DAO through their respective Divisional Officers/Executive Engineers.

Subject to eligibility, their pay in Level-10 of 7th CPC Pay Matrix will be fixed under Rule 13 of CCS (Revised Pay) Rules, 2016 notified vide Gazette Notification GSR 721 (E) F. No. 1-2/2016-1C dated 25.07.2016. They may exercise the option for fixation of pay on promotion within one month from the date of promotion.

As per Recruitment Rule for the post of Sr. DAO in Part-II, Section 3, Sub-Section (1) of Gazette of India vide GSR No. 10 dated 17.01.2020 published in Gazette of India on 25.01.2020, on their promotion, Sr. DAO will be on probation for a period of 2 (two) years followed by confirmation.

It is issued subject to further orders which may be passed by the Hon'ble Supreme Court as stipulated in para 5 of DoPT OM No. 36012/11/2016-Estt. (Res-I)(Pt-II) date 15.06.2018. Moreover, the promotion shall be subject to the judgement dated 28.01.2022 of the Hon'ble Supreme Court of India in Jarnail Singh & Ors in Civil Appeal No. 629/2022 arising out of SLP© No. 30621/2011 and further orders that may be passed by the Hon'ble Supreme Court of India as mentioned in DoPT's OM No. 36012/16/2019-Estt (Res.) dated 12.04.2022.
