- 4. Adverse comments by supervising officer/and the BE of the division on monthly progress report may impact completion of probation period and confirmation in the service of the concerned DA (P).
- 5. The DA (Ps) will be given independent charge after completion of probation period and confirmation in the service in terms of para 7 of guidelines issued by the Headquarters Office regarding Transfer and Porting of Divisional Accountants dated 16-08-2024.
