

The Senior Private Secretaries retiring upto 31-03-2025 can also apply.

The following terms and conditions will be applicable in this regard: -

- The retired officers / officials can be hired on a short-term contract basis initially up to a period of one year extendable up to a maximum of five terms or up to attaining the age of 65 years, whichever is earlier.
- Remuneration and allowances are governed by OM No: 3-25/2020-E.III A dated 09-12-2020 issued by the Department of Expenditure, Ministry of Finance, Government of India, New Delhi, which is as under: -
- a. The retired officers shall be paid a fixed monthly amount, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount so fixed shall remain unchanged for the term of the contract.
- b. Transport allowance not exceeding the rate applicable to the appointee at the time of his / her retirement shall be allowed .
- c. No annual increment / percentage increase, Dearness Allowance and House Rent Allowance shall be allowed during the contract.
- 3. Paid leave of absence shall be allowed at the rate of 1.5 days for each completed month of service. In case of absence, beyond paid leave in a month for reasons other than due to curfew, band, strike, lockdown; remuneration shall be deducted on pro-rata basis by dividing fixed monthly remuneration by 22 and multiplying the result to the number of days of absence on working days.
- 4. Duties assignable and other conditions shall be as envisaged in the Headquarters Office Circular dated 26-09-2023.
- 5. Statutory deduction levied by the Union Government shall be made from the monthly renumeration as per applicable Rules.
- 6. The appointment will be purely on temporary basis and will be subject to termination at any time.
