- 2. The payment on account of dearness relief involving fractions of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored.

All other conditions for payment of dearness relief to pensioners/family pensioners on revised pension/family pension contained in FD's instructions No. 2/23/2016-1Pension dated 03-03-2017, as circulated under No. Pen. Co-ordn./Haryana/Vol.- VII/Revision/57 dated 04-07-2017, shall be applicable.
- 4. Having been authorised by the Pr. Accountant General (A&E), Haryana in their authority No. Pen-1/Gen-26/DA/2024-25/859-936 dated 30-10-2024 (SSA No. 06 dated 29-10-2024), it is requested to make necessary arrangement for payment of dearness relief to all eligible Haryana Government pensioners/family pensioners @ 53% on their basic pension/family pension with effect from 01-07-2024 after proper adjustment.
