Sub: Nomination of officers for All India Training on Financial Audit

Regional Capacity Building & Knowledge Centre, Bengaluru will conduct a five day All India Training program on 'Financial Audit' from 06th to 10th January 2025 in offline mode for Group Officers, Senior Audit Officers and Assistant Audit Officers (Level-9 and above).

Group Officers desirous to attend the training may self-nominate via the SAI – Capacity Building Portal with the approval of their Head of Department (HoD) by 13th December 2024. The self-nomination facility is now available on the SAI Capacity Building portal. Self-nominated officers may also inform RCB&KC, Bengaluru with a copy of their HoD's approval. A consolidated list of recommended nominations will be sent to HQ for approval by PD(P) Wing. Five slots are allocated to PD(P) Wing for initiating self-nominations by Group Officers.

Group Officers whose nominations are approved by their HoDs may also nominate 2 Officers (SAO/AAO, Level-9 and above) from their office by 13th December 2024. Slots for SAO/AAO (Level-9 and above) will be allotted by this office in the SAI portal. Requests for slots must be made through the portal, and separate emails or letters are not required. The number of nominations for each office may preferably be restricted to two excluding Group Officers.

Training venue details will be shared with the nominated officers by 17th December 2024. As RCB&KC, Bengaluru does not have hostel facilities, participants are requested to arrange their own accommodation.
