*Subject : Revision of pension/family pension in respect of pre-01-01-2016
Himachal Pradesh Government Judicial pensioners/family
pensioners with effect from 01-01-2016.*

This is to state that the Government of Himachal Pradesh in their Department of Home Notification Nos. Home.B.B(10)1/2014-Vol-III-Loose dated 01-12-2023 and Home-B.B(10)1/2014-Vol-III-Loose dated 27-03-2024 has revised pension/family pension with effect from 01-01-2016 in respect of their retired Judicial Officers retired/expired prior to 01-01-2016, as under :

(a) In case of those who retired/expired prior to 01-01-2016, their pension/family pension will be revised in accordance with the principles laid down herein-

- i) Consolidated = Existing basic pension/family pension (as on 31-12-2015) x 2.81
- ii) Minimum assured pension/family pension = 50%/30% of revised entry level (copy enclosed) pay of their respective post
- iii) Revised pension/family pension = (i) or (ii) whichever is higher

2. The additional quantum of pension/family pension shall be made available to the Judicial Officers on completion of age of and at the rates specified below. This benefit of additional pension shall be available to all eligible pensioners/family pensioners with effect from 01-01-2016 :

Age of pensioner/family pensioner	Additional quantum of pension/family pension
75-80 years	20% of revised basic pension/family pension
80-85 years	30% of revised basic pension/family pension
85-90 years	40% of revised basic pension/family pension
90-95 years	60% of revised basic pension/family pension
95-100 years	80% of revised basic pension/family pension
On completion of 100 years and above	100% of revised basic pension/family pension

The expression 'years' in the above table shall mean completed years.

3. The existing period for restoration of commuted value of pension of 15 years will be continued.

4. Domestic Help Allowance to such pensioners and family pensioners @ Rs.9000/- (Rupees Nine thousand) and @ Rs.7500/- (Rupees Seven thousand and five hundred) only per month respectively shall be admissible with effect from 01-01-2016. This allowance shall stand increased by 30% on completion of five years from 01-01-2016 that is, with effect from 01-01-2021. The allowance shall be payable on the self-certification of such pensioners/family pensioners.

5. Medical Allowance @ Rs.4000/- (Rupees Four thousand) only per month shall also be admissible to such pensioners/family pensioners with effect from 01-01-2016.

6. In addition, consequent upon revision of pension/family pension as above, dearness relief sanctioned by the Central Government with effect from 01-01-2016 and thereafter, at revised rates, shall be payable with effect from 01-01-2016 on the revised basic pension/family pension as arrived at as per para 1. The rate and date of effect of dearness relief at present mentioned below :

Date of effect	Rate of dearness relief per month
From 01-01-2016	N I L
From 01-07-2016	2% of revised basic pension/family pension
From 01-01-2017	4% of revised basic pension/family pension
From 01-07-2017	5% of revised basic pension/family pension
From 01-01-2018	7% of revised basic pension/family pension

From 01-07-2018	9% of revised basic pension/family pension
From 01-01-2019	12% of revised basic pension/family pension
From 01-07-2019	17% of revised basic pension/family pension
From 01-07-2021	31% of revised basic pension/family pension
From 01-01-2022	34% of revised basic pension/family pension
From 01-07-2022	38% of revised basic pension/family pension
From 01-01-2023	42% of revised basic pension/family pension
From 01-07-2023	46% of revised basic pension/family pension
From 01-01-2024	50% of revised basic pension/family pension
From 01-07-2024	53% of revised basic pension/family pension

Dearness relief at revised rates indicated above will also be admissible on the additional basic pension/additional family pension available to old pensioners/family pensioners on the basis of age factor.

7. Payment of dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

8. Having been authorized by the Principal Accountant General (A&E), Himachal Pradesh in their authority Nos. Pension-1/Pension Special Seal/Himachal Pradesh/2024-25/857-97 (SSA-21/2024-25) dated 18-06-2024 (as well as through e-mail), Pension-1/C-5/Special Seal/Himachal Pradesh/2024-25/1145-84 dated 01-07-2024, letter No. T.M./15-2/Spl.Seal Sign/2024-25/824-56 dated 14-06-2024 (received under E-Mail dated 06-08-2024), it is requested to make necessary arrangement for payment of revised rate of pension/family pension and dearness relief to all eligible pre-01-01-2016 Himachal Pradesh Government Judicial pensioners/family pensioners with effect from 01-01-2016 along with arrear keeping in view the instructions laid down above and after proper adjustment.

9. Copies of the Order dated 01-12-2023 referred herein may be obtained from the website www.himachal.nic.in/home.

10. This order shall not be applicable to post-01-01-2016 Judicial pensioners/family pensioners of the Government of Himachal Pradesh. In their cases separate individual authorities will be issued from this office on receipt of necessary authorization from the Principal Accountant General (A&E), Himachal Pradesh.

11. The charges on this account are debitible to the head "8793-I.S.S.A/cs.; Govt. of Himachal Pradesh etc."
