### OFFICE ORDER

Subject: - Submission of Immovable Property Return for the year 2024 as on 31.12.2024.

In terms of Rule 18(1) (ii) of CCS (Conduct) Rules, 1964 read with Department of Personnel & Training's O.M. No. 11013/7/2014-Estt. A-III dated 05.01.2016, every Government servant holding Group 'A', 'B' and 'C' post is required to submit an annual return to the Government giving full particulars of his/her immovable property inherited by him/her or held by him/her on lease or mortgage either in his/her own name or in the name of any member of his/her family or in the name of any other person for the year 2024 as on 31st December, 2024 in the prescribed format latest by 31.01.2025.

- Full details of immovable property are to be given and expressions like "No change or same as last year" will not be accepted. If an officer does not own any property, he/she should state so in the return rather leaving it blank and it should be duly signed by the officer with date.
- As per DoPT O.M. No. 11012/11/2007-Estt. A dated 27.09.2011, the officers who fails to submit the Immovable Property Return by the prescribed time would be denied vigilance clearance and will not be considered for empanelment for promotion in senior level posts and deputation etc.
- All officers/officials holding Group 'A', 'B' and 'C' post are, therefore, directed to submit the immovable property returns for the year 2024 (i.e. from 01.01.2024 to 31.12.2024) in the prescribed format latest by 31.01.2025 positively.
- All Sr. Accounts Officers/Assistant Accounts Officers/Supervisors are hereby directed to ensure that all the officers/officials under their jurisdiction submit their returns latest by 31.01.2025 for the year 2024.
