Subject : Grant of dearness relief with effect from 01-07-2023 and 01-01-2024 to the pre-2016 Tamil Nadu Government pensioners/family pensioners on their un-revised pension/family pension.

In continuation to para 2 of this office circular No. Pen. Co-ordn./Tamil Nadu/Vol.-VII/DR-Pre-06&Pre-16/126 dated 20-11-2023, this is to state that the Government of Tamil Nadu in their G.O.(Ms.) Nos. 330 dated 09-11-2023 and 204 dated 11-06-2024 has sanctioned dearness relief to their pre-2016 pensioners/family pensioners, whose pension/family pension have not been revised as per Tamil Nadu Government G.O.(Ms.) No. 313 dated 25-10-2017, circulated under Pen. Co-ordn./Tamil Nadu/Vol.VII/Revision/208 dated 21-03-2018, as under :

3. The amount of dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee if such fraction is 50 paise and above and shall be ignored if it is less than 50 paise.

4. Having been authorized by the Principal Accountant General (A&E), Tamil Nadu in their authority No. PAG (A&E)/Pen-29/V/Pt:35971/2024-25/35825 dated 30-10-2024, it is requested to make necessary arrangement for payment of dearness relief to the Tamil Nadu Government pensioners/family pensioners on their un-revised pension/family pension at the rates and from the dates mentioned above after proper adjustment.

5. The charges on this accounts are debitable to the head "8793-I.S.S. A/cs.; Government of Tamil Nadu etc."
