## OFFICE ORDER

Consequent on passing the Divisional Accountants Grade Examination September-2024, the following Divisional Accountants (Probationers) of Mumbai region have been posted as Divisional Accountants in public interest to the divisions mentioned against their names under supervision of the officers mentioned in column No.3 with immediate effect.

Following instructions are hereby issued for the officers holding Supervisory charge and the DA (Probationers):

- 1. The official holding supervisory charge, and not the DA (P), will be responsible for preparation of accounts of the division. The Supervising official will be held responsible for the lapse, if any.
- 2. DA (P) is not authorized to sign any official documents until completion of the probation period and confirmation in the service.
- 3. The DA (P) will be responsible for preparing a monthly progress report till confirmation in service. The progress report will be examined and signed by the supervising officer and the Executive Engineer of the division. The monthly report is to be forwarded to the office of the Principal Accountant General (A&E)-II, Maharashtra, Nagpur by the supervising officer by 10<sup>th</sup> of each succeeding month.
- 4. The Supervising Officers shall ensure that the official documents being submitted to them at the divisions are submitted through the Divisional Accountants (Probationers) posted therein so that they can understand and learn the processes involved.
- 5. The Supervising Officers shall ensure that the Divisional Accountants (Probationers) are suitably trained regarding duties and responsibilities of Divisional Accountants with respect to ongoing work at the divisions.
- 6. Adverse comments by supervising officer/and the Executive Engineer of the division on monthly progress report may impact completion of probation period and confirmation in the service of the concerned DA (P).
- 7. The DA (Ps) will be given independent charge after completion of probation period and confirmation in the service in terms of para 7 of guidelines issued by the Headquarters Office regarding Transfer and Posting of Divisional Accountants dated 16-08-2024.
