## Sub: - Calling for application from intending eligible candidates to appear at the ensuing Divisional Accountant Grade Examination scheduled to be held in March, 2025.

Under Para-7.10 of CAG & AG's MSO (Admn.) Vol-1 (3<sup>rd</sup> edition), passing of Divisional Accountant Grade examination is necessary for a person to be appointed as Divisional Accountant. For this purpose Principal Accountant General organizes 'Divisional Accountant Grade Examination' twice a year during the month of **March & September** as per Para 7.8 of the above said manual.

Besides, candidates will be required to pass language test in Odia as prescribed departmentally. Candidates who have passed H.S.C examination or equivalent/Higher examination with Odia as one of the subject are exempted from appearing at the language test in Odia provided they furnished documentary evidence to that effect.

The syllabus of the examination is given in Annexure to the Chapter –VII of the C.A&G's Manual of standing Order (Admn.) –Vol-I. The pattern of Questions for the above said examinations except Paper –I will be MCQ in accordance with Headquarters Office Examination Wing Circular No. 01 of 2022 issued vide letter No.04/08-Exam/Syllabus Revision/2021 Dated 06.01.2022 and Clarification(s) subsequent to change of pattern to MCQ in all department examinations Circular No.10 of 2022 issued vide letter No-145/07-Exam Clarification MCQ Pattern/2022 Dated 24.03.2022.and there will be negative mark of 0.25 for each incorrect answer.

The examination is scheduled to be held from **25.03.2025** to **29.03.2025** as per <u>Headquarters</u> <u>Examination Wing letter dated-22.01.2025</u>.

All Divisional Accountants (Probationer) who have completed one year of training as on 24.03.2025 are eligible for appearing in Divisional Accountant Grade Examination. Divisional Accountants (Probationer) who have deficiency of **not exceeding two months** in the **minimum period of one year training as on** 24.03.2025 may apply provided their deficiency is condoned by the competent authority as per Para 7.7(IV) of CAG' MSO (Admn.) Vol-I (3<sup>rd</sup> edition).

Eligible Divisional Accountants (Probationer) intending to appear the Divisional Accountant Grade Examination may submit their application to WM Section through e-mail (<u>braepuri@cag.gov.in</u>) latest by 28.02.2025 in prescribed Pro-forma attached.

Incomplete applications will summarily be rejected, and applications received after last date shall not be entertained.
