Sub:- Incentive Examination for Sr. Accountants- April 2025.

The next Incentive Examination for Sr. Accountants is scheduled to be held in the month of April 2025. Sr. Accountants (Accounts) with one-year continuous service in the grade as on 01.04.2025 and Assistant Supervisor who have not passed the Incentive Examination for Sr. Accountant are also eligible to appear the said examination. Eligible candidates intending to appear in the said Examination may submit their applications in prescribed Proforma available in Admn.I / (download the application form office website link <https://cag.gov.in/ae/odisha/en/ae-circulars-office-orders?cat=853>) through proper channel on or before 21.03.2025. Applications received after due date will not be considered.

In terms of Headquarters Examination Wing Circular 01 of 2024 dated 17.01.2024, it has been decided to conduct the Incentive Examination for Sr. Accountants centrally by Examination Wing of Headquarters office on offline mode w.e.f July 2024 as per the examination cycle mentioned in C&AG's MSO (Admn) Vol-I.

Earlier, in terms of Examination Wing of Headquarters office Circular 01 of 2022 issued vide letter No. 04/08-Exam/Syllabus Revision/2021 dated 06.01.2022, it has been decided to reform the pattern of Incentive Examination for Sr. Accountants which are being conducted locally by the Heads of the Department in conventional mode to Multiple Choice Questions (MCQ) pattern with effect from the date of issue of the said circular.

The Examination will be held according to the revised syllabus of Incentive Examination for Senior Accountants communicated vide Examination Wing Circular 02 dated 12.07.2024.

In terms of Examination Wing Circular 02 of 2024 dated 12.07.2024 there will be one Paper (Finance & Government Accounts) of 2-hour duration for 100 marks consisting of Section-I: Constitution of India, Section-II Regulations on Audit & Accounts, 2020, Section -III: IT Theory, Section IV: Civil Accounts Manual, 2007.

Negative marking to the extent of 0.25 mark (25 %) is introduced to maintain quality and to guard against guess work. The candidates are required to write the examination without the aid of books, and they have option to answer the Paper either in English or Hindi.


The Venue, Date and Time of the examination will be intimated in due course.
